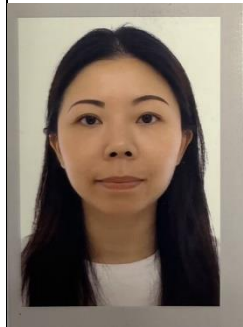
Vision Statement
